The upper age limit is relaxable for the reserved categories as per the existing norms enumerated vide Govt. OM No. ABP.06/2016/4 dated 03/03/2016 and No. ABP.06/2016/8 dated 18/04/2018. The age of the candidates will be calculated on the basis of Matriculation Certificate/HSLC Admit/ HSLC passed Certificate issued by a recognized Board of Education/ Council. No other documents shall be acceptable in lieu thereof for the purpose.

#### 2. Educational qualification-

- a. The minimum educational qualification of the candidates shall be a Graduate in Arts/ Science/Commerce from a recognized State/ Central University or a Degree equivalent thereto and recognized by the State/Central Government.
- Candidates must have proficiency in basic Computer applications like MS Window, Linux, MAC, EXCEL, PowerPoint, DTP (English/Assamese) and Internet processing etc.
- Candidates must have obtained a minimum 6 (six) months Diploma in Computer Application from an Institute recognized by State/Central Government.
